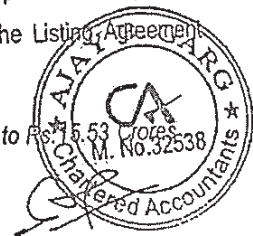
Scope of Review

Accordingly, we do not express an audit opinion.

a) No provision has been made against performance bank guarantees invoked total amounting to Rs. 15.53 Crores against the company and disputed by it.



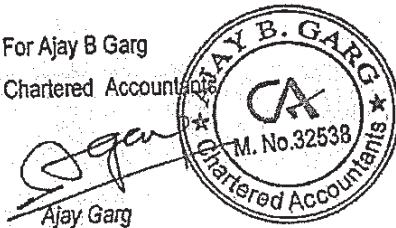
